I want to tell the tale of someone I will call Janelle although the name is fictitious: Janelle (age 32) comes down with a urinary tract infection. It is Saturday so her regular doctor's office is closed. The UTI is so painful that she decides she cannot wait until Monday to get treatment. She goes to an Emergency Services Clinic close to her house. She tells them that she has a urinary tract infection and they write her a prescription for Cipro (Ciprofloxacin – a fluoroquinolone antibiotic). They do not culture her urine because they do not have the time or capacity to do so. It does not matter what kind of bacteria is in her urine, they know that Cipro will kill it because Cipro is a broad-spectrum antibiotic that will kill all the offending bacteria in her urinary tract, plus some. Janelle is relieved. Her painful

urinary tract and bladder are about to be healed. Janelle takes two 500 mg. pills of Cipro two times a day for a week. On the 5th day of taking Cipro, She starts to feel a bit off. Her bladder feels full even when it is not, she has dark "floaters" interfering with her vision and she feels anxious. She passes these things off as nothing much but a little unusual, yet not too worrisome. She does not think for a second that they could be due to the antibiotic that she is taking. Janelle finishes the seven day course of Cipro. Her urinary tract infection is gone and she is pleased about that. Her bladder fullness, floaters and anxiety come and go and she still ignores them for the most part. Ten days pass and Janelle feels fine. However, on the eleventh day after she has finished taking Cipro, she starts taking ibuprofen to treat menstrual cramps. On the thirteenth day after she has finished taking the Cipro, it feels as if a bomb goes off in her body. Her hands and feet swell to twice their normal size. It becomes painful for her to walk or to do anything with her hands. Her knees are burning as if every tendon in them is inflamed. She is weak and develops hives all over her body. Now her anxiety levels are sky-high. Janelle goes to the doctor. The doctor says that the hives are a result of an allergic reaction and tells her to take Benadryl. Janelle asks the doctor why she can barely walk when she was going to the

gym daily just a few days earlier. The doctor says that she does not know, but that she will run tests. Janelle takes Benadryl but it does not seem to help. She goes back to the doctor for something stronger and is put on prednisone. The swelling in her hands and feet goes down, but her other symptoms worsen. She develops insomnia. She sprains her wrist while opening a jar. Intermittent pain throughout her body, but especially in her legs, begins. She loses her memory and has trouble concentrating. Her test results come back. They are all "normal." Her pain worsens. She is diagnosed with Fibromyalgia. She asks the doctor, who diagnoses her with Fibromyalgia, how she could have gone from being healthy and active to being disabled and in pain, now with a diagnosis of Fibromyalgia. The doctor mutters something about mysterious diseases and unexplained symptoms. Janelle asks if her symptoms could be related to any of the medications that she took – Cipro, ibuprofen and prednisone. The doctor assures her that it was not. More tests are run to see if there are other causes of Janelle's symptoms. Janelle is put on Lyrica to help her with her Fibromyalgia pain. The Lyrica seems to help some of her pain but her mental symptoms get worse while she is on it. In addition to her already existing memory and concentration problems, Janelle develops brain-fog.

She feels slow, stupid and like she is living in a dream. She gains 15 pounds in two months. Her hair starts to fall out. She feels suicidal. She is taken off of Lyrica by her doctor. Janelle continues to have problems in her joints, especially her wrists, knees and ankles, so she is not surprised when she is diagnosed with Rheumatoid Arthritis. Janelle starts seeing a Rheumatologist who puts her on Humira. Humira decreases some of her inflammation symptoms but many of her other symptoms remain. She receives Humira treatments for 2 years. After two years of Humira treatments, Janelle is diagnosed with hepatosplenic T-cell lymphoma – cancer. She dies on the operating table when her surgeon attempts to remove the lymph nodes on her neck that had been affected by the cancer. She is 36 years old when she passes away. Janelle's story is far from fantasy. Stories like hers happen every day. A large portion of her story is for many both true and horrifying to experience. ***** Fluoroquinolone ANTIBIOTICS are the "first antibacterial agents that ably inhibited DNA replication." They also form "a poisonous adduct on DNA".

Fluoroquinolones cause chromosomal abnormalities in human cells. Fluoroquinolones cause apoptosis, which is programmed cell death, at a massive rate. Good and bad cells are not distinguished by the drug.

Fluoroquinolones have fluoride as a central part of the drug. Fluoride is a known neurotoxin, and drugs with an attached fluoride can penetrate into very sensitive tissues.

The fluoroquinolones have the unique ability to penetrate your blood-brain barrier, entering your brain and damaging your central nervous system. Many of these drugs have already been removed from the market due to their toxicity, and those that remain are riddled with black box warnings required by the U.S. Food and Drug Administration (FDA).

Fluoroquinolones are among the most commonly prescribed class of antibiotics in the United States. All antibiotics carry a risk of side effects, but the fluoroquinolones are in a class by themselves when it comes to their potential to cause serious, permanent injuries and even death. Given their potential to harm, they should be reserved for treating only the **most serious bacterial infections** that will not respond to any other treatment and then the risk needs to be considered; instead, they are often offered for mild conditions like sinus, urinary tract and ear infections.

Levaquin, for instance, which was the best-selling antibiotic in 2010, faces thousands of lawsuits a year from people who have been seriously harmed after taking it. The reactions can be body-wide, impacting your central nervous system, musculoskeletal, visual and renal systems, sometimes simultaneously. Among the serious reactions reported are: retinal detachment, which can cause blindness, acute kidney failure, brain fog, depression, hallucinations, nausea and diarrhea, psychotic reactions, hearing problems, brain fog, painful rashes, disruptions to blood sugar metabolism, depression, phototoxicity, peripheral neuropathy

In a 2001 study by Dr. Jay Cohen, the following reaction rates were documented:

- Nervous system symptoms occurred in 91 percent of patients (pain, tingling and numbness, dizziness, malaise, weakness, headaches, anxiety and panic, loss of memory, psychosis)
- Musculoskeletal symptoms in 73 percent of patients (tendon ruptures, tendonitis, weakness, joint swelling)
- Sensory symptoms in 42 percent of patients (tinnitus, altered visual, olfactory, and auditory function)
- Cardiovascular symptoms in 36 percent of patients (tachycardia, shortness of breath, chest pain, palpitations)
- Skin reactions in 29 percent of patients (rashes, hair loss, sweating, intolerance to heat or cold)
- Gastrointestinal symptoms in 18 percent of patients (nausea, vomiting, diarrhea, abdominal pain)

In most cases, doctors have dismissed the complaints or outright denied that the reactions could occur with fluoroquinolones. Yet extensive medical workups do not find any other cause. Worse, there are no known effective treatments. Thus, these people suffer pain and disability for weeks, months, and years.

A large part of the problem is that these drugs, which are meant to be reserved for **life-threatening infections** that cannot otherwise be treated, are being vastly overused. *The New York Times*: In an interview, Mahyar Etminan, a pharmacological epidemiologist at the University of British Columbia, said the drugs were overused "by lazy doctors who are trying to kill a fly with an automatic weapon." These drugs are thought to be particularly dangerous for children under age 18, adults over 60, and pregnant and nursing women, as well as people with liver disease or those taking corticosteroids or nonsteroidal anti-inflammatory drugs (NSAIDs). But, they are often prescribed for these groups, anyway.

If your doctor prescribes you one of these dangerous antibiotics you can ask him or her to use another one. You have a voice. It is uncommon that this would be the only one that could be used. These dangerous antibiotics should be used as a last resort only. In today's expansive age of online networking, there exists a large community of people who've experienced fluoroquinolone injuries. They often refer to themselves as the "Floxies," and their numbers continue to grow as the prescriptions flow.

You would not knowingly risk permanent blindness, personality changes or psychotic reactions to treat your ear infection, especially if there were a safer alternative... and there nearly always is. David A. Flockhart, professor of medicine and chief of clinical pharmacology at Indiana University School of Medicine, reports as many as one-third of patients taking a fluoroquinolone will experience some sort of negative psychiatric effect, such as anxiety, personality changes, or confusion. He has treated more than 100 patients with such psychiatric side effects, stating:

"The psychiatric effects of the fluoroquinolones are underappreciated by the medical profession as well as by the public. The bigger the gun you use, the more damage you can expect as collateral."

Cipro, Levaquin and the related drugs in the class are very "big guns" that should only be used in very special circumstances. Please be absolutely sure your circumstance is one of them before consenting to use these drugs.

- ciprofloxacin (Cipro)
- levofloxacin (Levaquin/Quixin)
- gatifloxacin (Tequin)
- moxifloxacin (Avelox)
- ofloxacin (Ocuflox/Floxin/Floxacin)
- norfloxacin (Noroxin)

Leaving the fluoroquinolones for a moment and dealing with another drug Janelle was given was

Humira: According to an article recently published in the *Journal of the American Medical Association*, patients taking the rheumatoid arthritis drugs Remicade® (infliximab) or Humira® (adalimumab) had a three-fold increased risk of developing various types of cancers.

The medical profession gave the side effects of medications a label no test can prove called fibromyalgia. This makes the patient happy because the pain and suffering that they experience is very real, and finally they think they have the answer. No one is willing to take the responsible approach that their symptoms are caused by a reaction to their medication. There is no test to reveal fibromyalgia, yet all the symptoms can be read on the prescription labels.
